Introduction

Background

The Department of Health and Human Services (HHS), Administration for Children and Families (ACF), Children's Bureau is responsible for the implementation and management of the Adoption and Foster Care Analysis and Reporting System (AFCARS). State and Tribal title IV-E agencies (collectively referred to as agencies) are required to report AFCARS case-level information on all children in foster care and children who have been adopted with title IV-E agency involvement (per §479 of the Social Security Act). The regulations were updated via the final rule published in May 2020 (85 FR 28410). Agencies have until October 1, 2022, to prepare their data systems to collect and report AFCARS 2020 data. The first submission of AFCARS 2020 is due May 15, 2023.

Two 6-month report periods exist based on the federal fiscal year: October 1 to March 31 (A submission) and April 1 to September 30 (B submission). The agency must submit the Out-of-Home Care and Adoption and Guardianship Assistance data files to the Children's Bureau within 45 days of the end of the report period (by May 15 and November 14). If the reporting deadline falls on a weekend, the agency has until the following Monday to submit the data file.

About the Technical Bulletin

This technical bulletin provides agencies with the information required to create the AFCARS data files.

In accordance with 45 CFR 1356.85(a)(2), agencies must submit AFCARS data files in a format that meets ACF specifications. This technical bulletin outlines these specifications, including the following requirements for the structure of the AFCARS data files:

- The Extensible Markup Language (XML) structure of the AFCARS data files to be used in the transmission of data to the AFCARS system; and
- Guidelines for assigning and encrypting record numbers of youth reported to AFCARS.

This technical bulletin does not cover the specifics of the data file submission process. The Children's Bureau is developing a new enterprise-wide engineering and architecture service to support agencies' AFCARS submissions. The National Child Welfare Data Management System (NCWDMS) is scheduled to be ready for the first AFCARS 2020 submission in May 2023. Additional resources on NCWDMS will be available as the new system is built and ready for use.

The original version of this technical bulletin was released on January 19, 2021. This revised version changes the Out-of-Home Care File schema slightly to remove the maximum number of entries for some of the elements. It changes the limit from "99" to "unbounded" for the number of removals and living arrangements, along with other elements. It also contains minor edits to Appendix C.

Data File Structure

Overview of XML

Extensible Markup Language (XML) uses tags (indicated by angle bracketed labels) to mark up, structure, and annotate data in a way that is both readable by computers and legible to users.

Extensible means that users can define and extend markup elements to meet their own requirements.

The Children's Bureau chose XML for use with the AFCARS data file because it offers distinct advantages as a file format.

- XML is stored in plain text, for maximum system compatibility.
- XML is widely used and is based on defined standards.
- Because of its extensibility, XML may be tailored to the requirements of AFCARS.
- XML is self-documenting, so the markup provides semantic information on the file contents.
- XML provides a flexible means of providing contextual structure to hierarchical and other complex data.
- XML is easily parsed, so the marked-up information may be read and extracted from the file without difficulty.

Requirements for the Structure of AFCARS XML Data Files

- A valid transmission will consist of two files: an Out-of-Home Care data file and an Adoption and Guardianship Assistance data file.
- The data files will be well-formed XML documents in accordance with defined World Wide Web Consortium (W3C) XML standards (see <http://www.w3.org/TR/REC-xml>).
- The overall structure of each XML data file is dictated by an associated W3C XML Schema ([Appendix E](#) and [Appendix F](#)).
- The XML structure of each must begin with a proper XML declaration specifying UTF-8 character encoding: `<?xml version="1.0" encoding="utf-8"?>`.
- Only the 128 characters defined by the ASCII encoding schema may be included in the data, except for the record number (element 4 – Child Record Number in the Out-of-Home Care data file and element A3 – Child Record Number in the Adoption and Guardianship Assistance data file).
- The record number must contain only printable UTF-8 characters and exclude the defined control characters (such as 0 to 31, and 127) and the unassigned characters (such as 129, 141, 143, 144, 157).
- All data within XML element tags must exclude the following characters with special syntactic meaning in XML:
 - the ampersand character (&),
 - the left-angle bracket character (<),
 - the right-angle bracket character (>),
 - the single quotation mark ('), and
 - the double quotation mark (").

XML Data Tags

The naming convention for XML tags is based on the AFCARS data elements, as defined in [Technical Bulletin #20](#). The name of the XML tag for an AFCARS element consists of an initial “E” for an element in the Out-of-Home Care data file or “A” for an element in the Adoption and

Guardianship Assistance data file, plus the element number, followed by a descriptive name in lower-case, with underscores separating words, for example:

<E1_title_iv_agency> = Element 1: Title IV-E Agency (in the Out-of-Home Care data file)

<A1_title_iv_agency> = Element A1: Title IV-E Agency (in the Assistance data file)

A list of the XML tags for each AFCARS data element listed in [Technical Bulletin#20](#) is provided in [Appendix C](#) and [Appendix D](#).

AFCARS Data File Structural Hierarchy

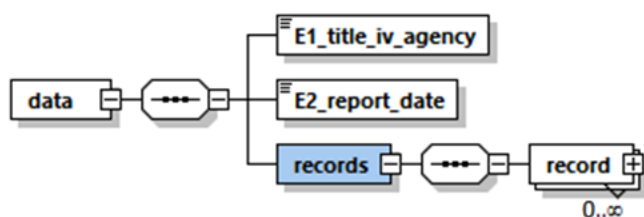


Figure 1. Structural Hierarchy for Out-of-Home Care File

XML provides a structural hierarchy to a data file by organizing the data into nested sets of tags to reflect one-to-many or other dependent relationships between elements. For example, one child may have multiple removal episodes recorded. **Figure 1** shows an overview of an AFCARS data file's structural hierarchy. The data for both AFCARS XML files is nested within the top-level XML tag, <acf:data>. Directly within this are two data elements pertaining to the entire file - the title IV-E agency and the reporting period. The remainder of the file consists of records for each individual child.

Grouping of Elements

The XML schema for each file groups certain elements for two purposes:

1. To logically group a set of related elements; and
2. To nest an element, or series of elements, that can occur more than once, e.g., removal episodes or periodic reviews.

Both the Out-of-Home Care data file and Adoption and Guardianship Assistance data file consist of a top level (root) element, <acf:data>. AFCARS data elements containing data global to the whole file are included directly under <acf:data>, e.g., <E1_title_iv_agency>. Beneath <acf:data> each file includes a group element, <records>, which contains multiple <record> group elements: each child <record> corresponds to all the AFCARS data for an individual child. [Appendix A](#) and [Appendix B](#) show diagrams of the groupings.

The Out-of-Home Care data file contains several group elements. As a matter of convention, each group element name describes the range of AFCARS data elements it comprises.

Logical grouping example:

- [<E7 E12 tribal information>](#): contains a logical grouping of Indian Child Welfare Act (ICWA)-related AFCARS data elements 7-12, which is visually represented in Appendix A.
- [<E24 34 specific health conditions>](#): contains a logical grouping of health-related AFCARS data elements 24-34; also visually represented in Appendix A.

Series element grouping example:

- [<E112 E146 living arrangement>](#): contains a series of element groupings of living arrangement-related data elements 112-146. The visual representation is shown in Appendix A.
- [<E151 E152 case worker visit>](#): contains a series of element groupings of case worker visit-related data elements 151-152. The visual representation is shown in Appendix A.

Grouping of Removals

Two different grouping types exist for a removal episode. Agencies must report all AFCARS 2020 elements for a current removal episode. However, agencies report only three elements for any removal episode that started and ended before October 1, 2022 (the first day of the first AFCARS 2020 reporting period). The three elements are element 69 – Date of Removal, element 153 – Date of Exit, and element 155 – Exit Reason.

The Out-of-Home Care XML schema ([Appendix E](#)) provides a distinction between the prior removals and all others by defining two different removal grouping elements:

- `<removal_1993>`
- `<removal_2020>`

A `<removal_1993>` grouping element only contains elements 69, 153, and 155, while a `<removal_2020>` grouping contains all removal-related elements (elements 3, 69-105, and 112-186). An agency reports each removal episode for a child in one of the two removal groupings. The visual representation of this grouping is shown in Appendix A.

Encryption

Overview

To protect confidentiality of the child when the agency reports case-level data to the Children's Bureau, agencies are required to use an encrypted, unique number. This record number is reported in element 4 – Child Record Number in the Out-of-Home Care file and element A3 – Child Record Number in the Adoption and Guardianship Assistance file.

The child record number is a unique ID which remains the child's constant identifier from intake through the life of the child's interaction with the agency. The agency encrypts the identifier to transmit the data confidentially to the Children's Bureau. The encrypted ID must be a 12-character identifier that cannot be linked to the child except at the agency or local level. It is important that outside agencies, including the Children's Bureau, not be able to decrypt the encrypted record number submitted to AFCARS.

An agency is responsible for its own encryption routine using modern and accessible encryption tools and the information provided in this technical bulletin.

This approach is congruent with the requirements for submission to the National Youth in Transition Database (NYTD). For purposes of the Federal Child and Family Services Reviews (CFSR) and the title IV-E out-of-home care eligibility reviews, agencies must be able to identify the case file for a specific child record for at least three years. The Children's Bureau also uses the encrypted IDs across different submission periods to develop comprehensive data files that follow children through their experiences in care.

Encryption Guidelines

Agencies that already have an established AFCARS-conformant encryption method should continue using that methodology. If an agency finds a need to change its encryption method and this results in a change in the child's encrypted ID from one submission to the next, the agency will need to work with the Children's Bureau to assure there is a way to match the records from one submission period to the next. If an agency is new to submitting AFCARS, it is recommended that it adopt the use of encryption tools and methods that meet the needs of the agency and the Children's Bureau as specified in this technical bulletin.

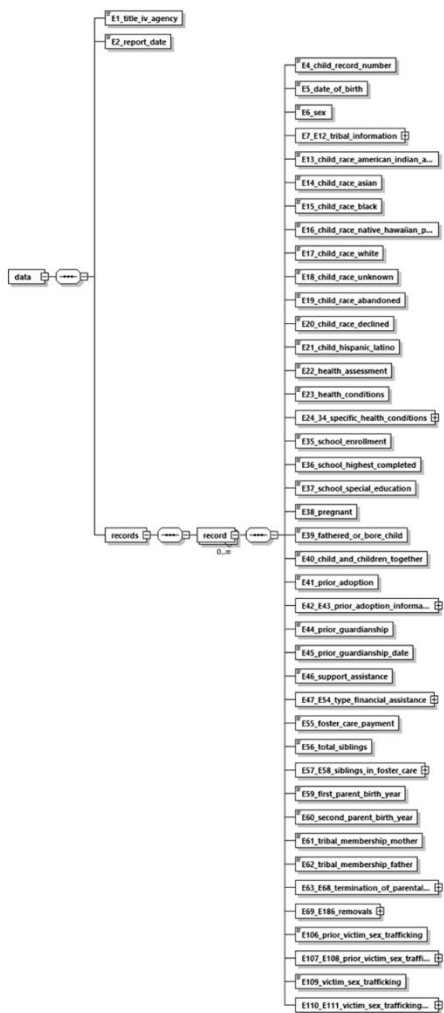
All methods must adhere to the following guidelines:

- All AFCARS records must have a unique encrypted record number.
- The encryption methods the agency uses must report the same result every time the procedure is executed. Thus, the child ID must always yield the same encrypted AFCARS record number after processing.
- The agency should be able to reverse the process and determine the original child ID for all AFCARS record numbers. The agency must maintain any algorithms, tables, and keys used to generate the unique, encrypted ID.
- The agency must keep the method of encryption secure. Only authorized personnel should have access to it.

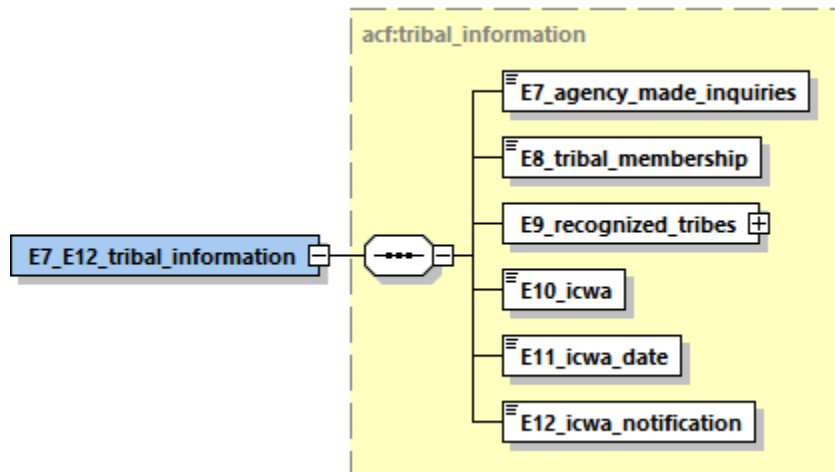

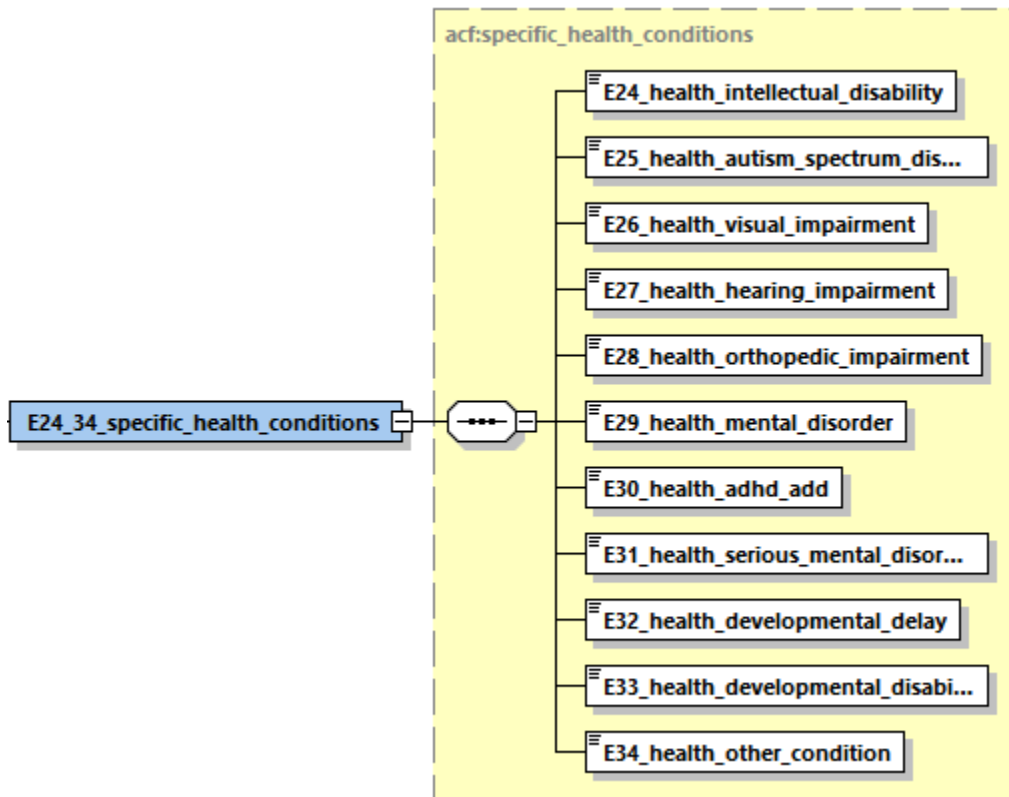

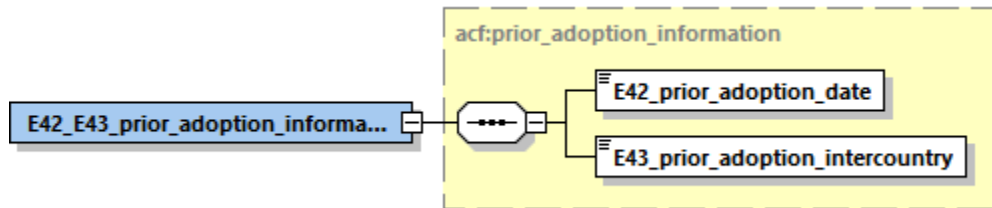

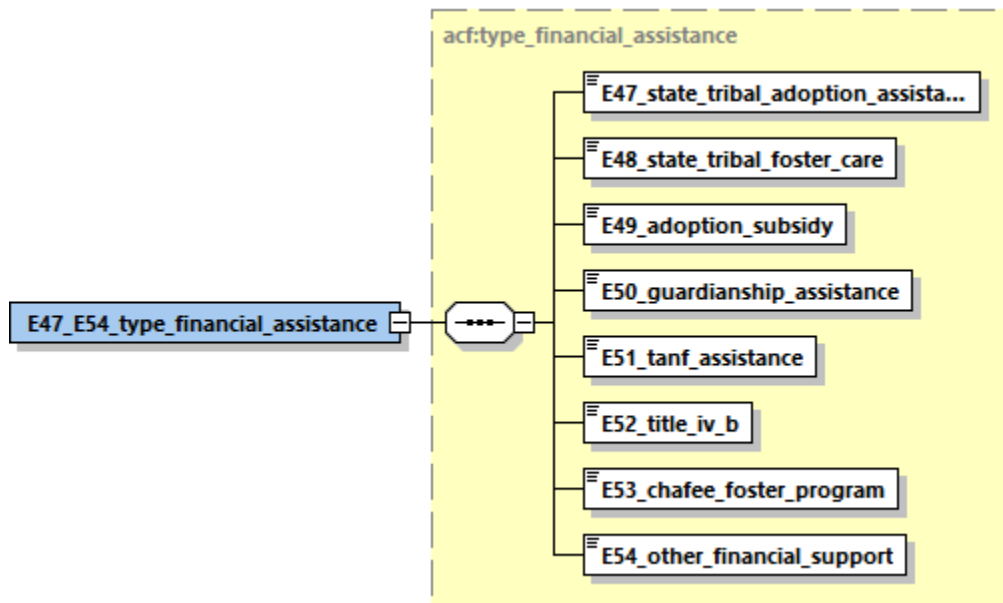
Specific Health Conditions



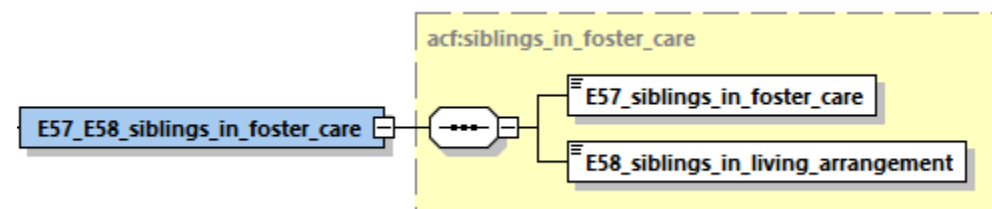
Prior Adoption Information



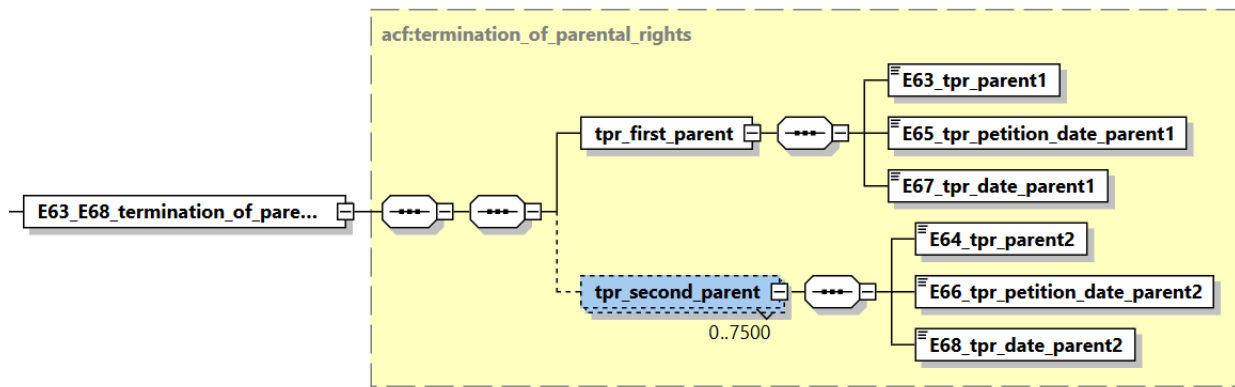

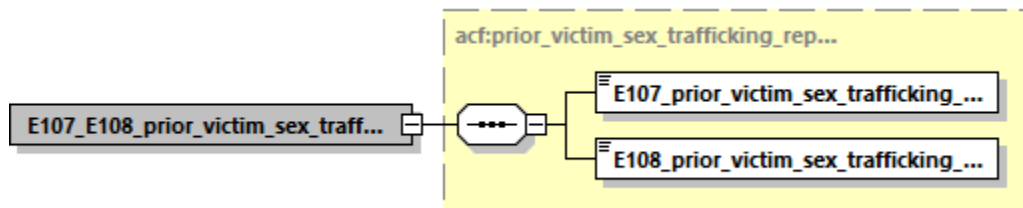
Siblings in Foster Care



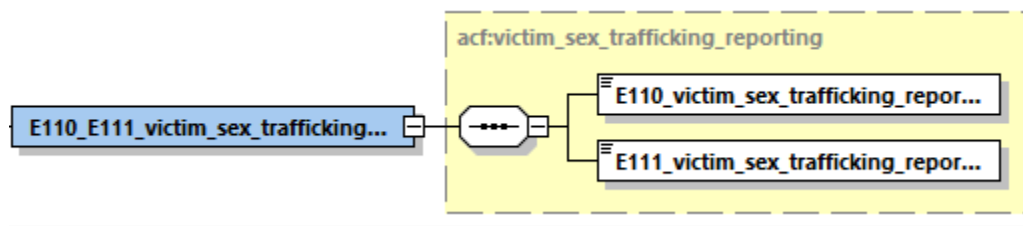
Termination of Parental Rights



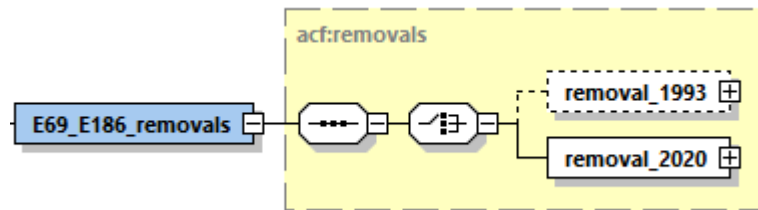

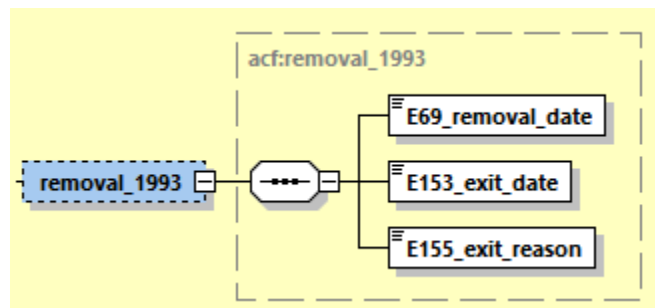

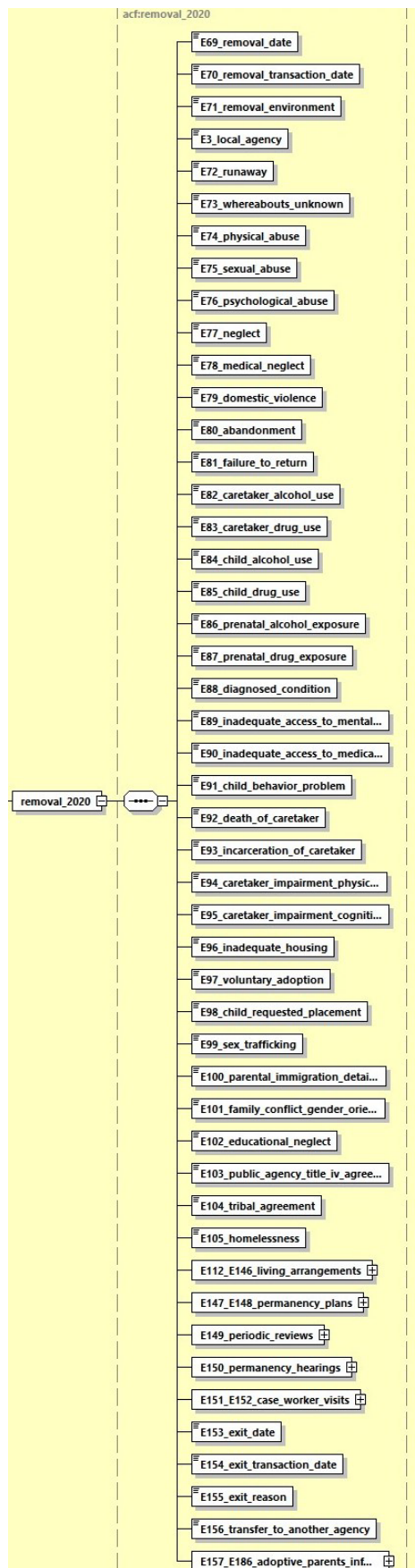

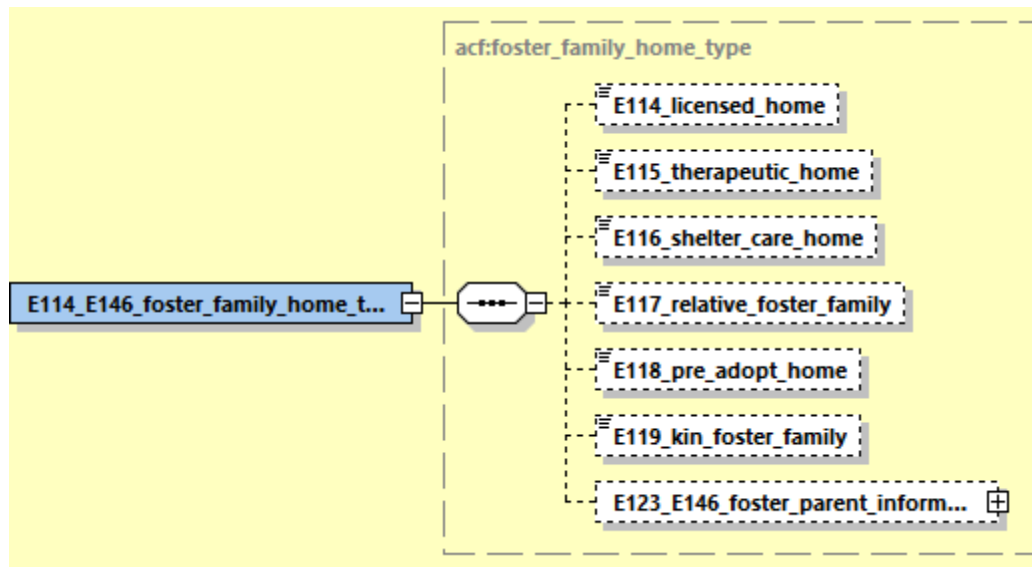

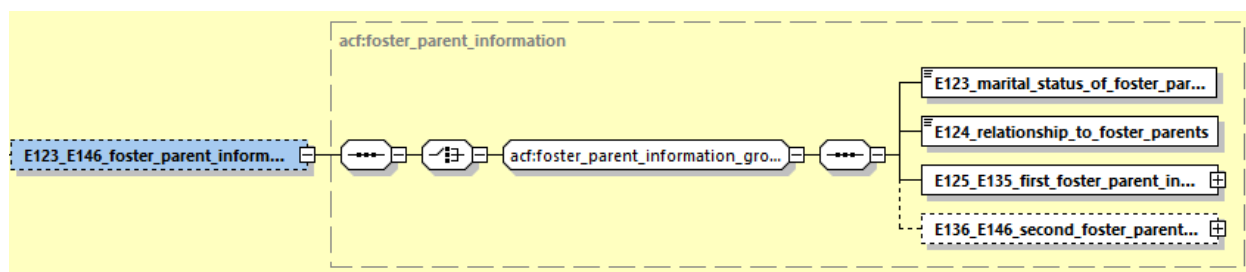

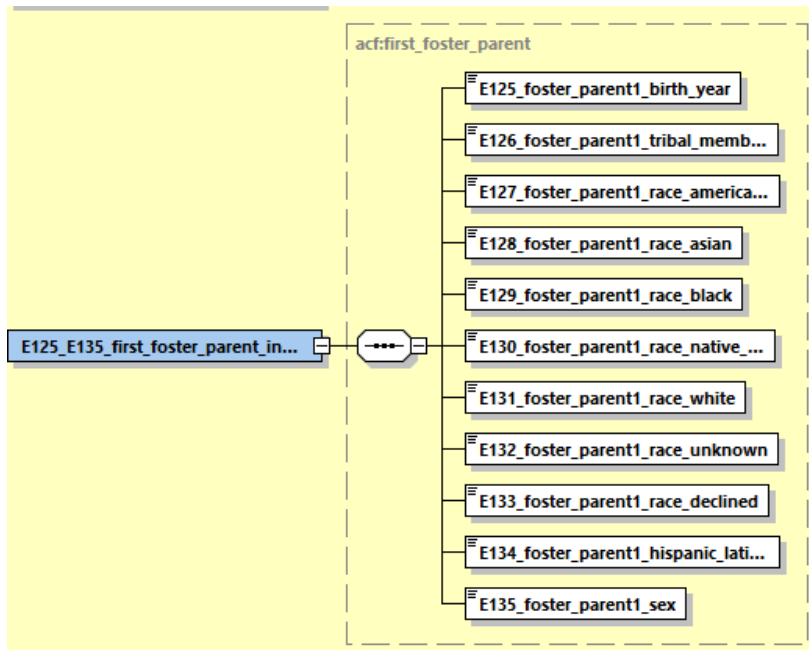
Foster Family Home Type



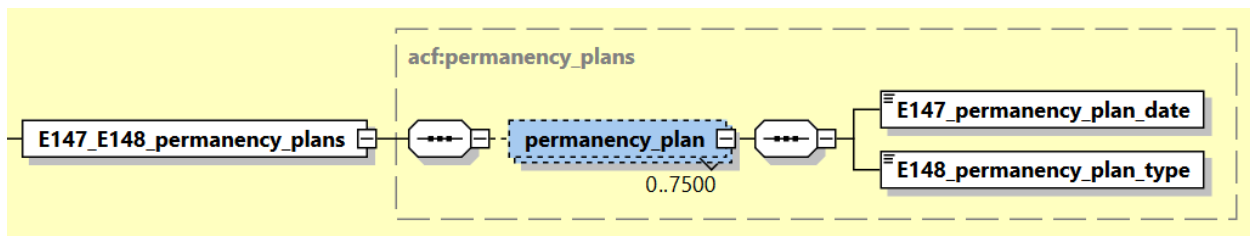
Foster Parent Information



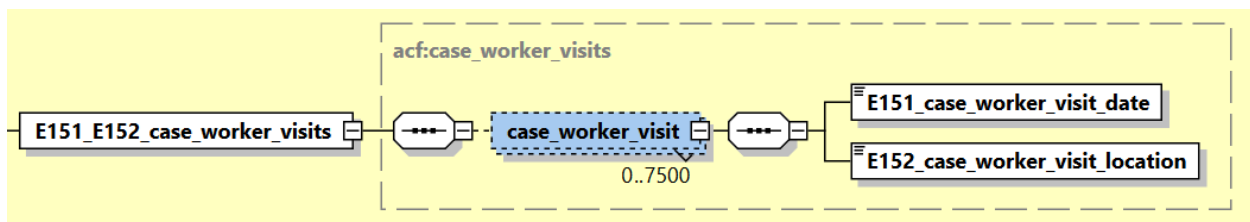

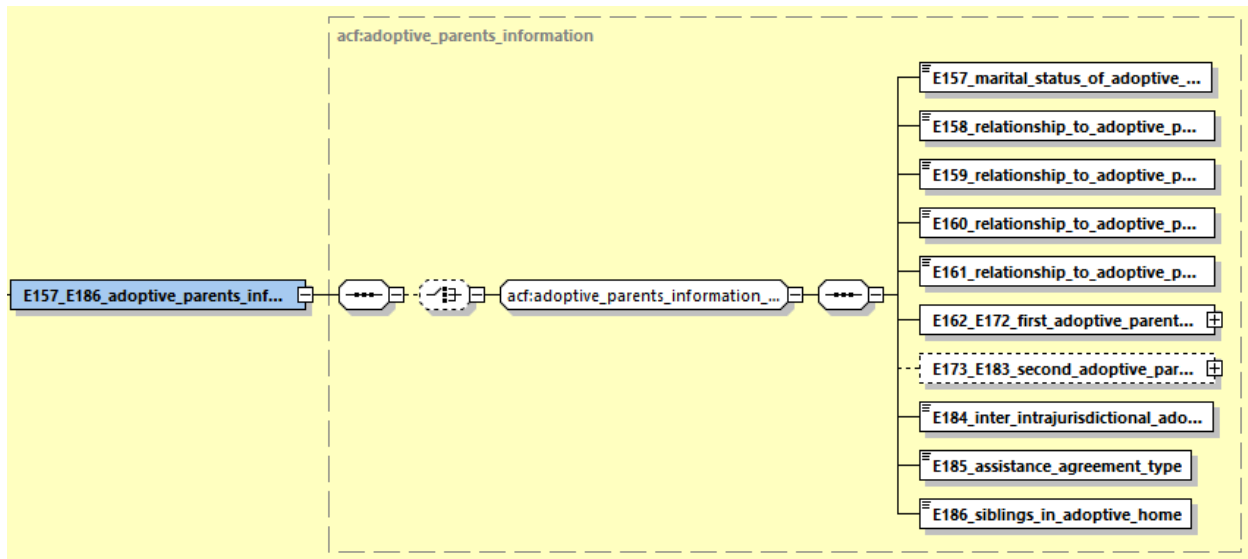

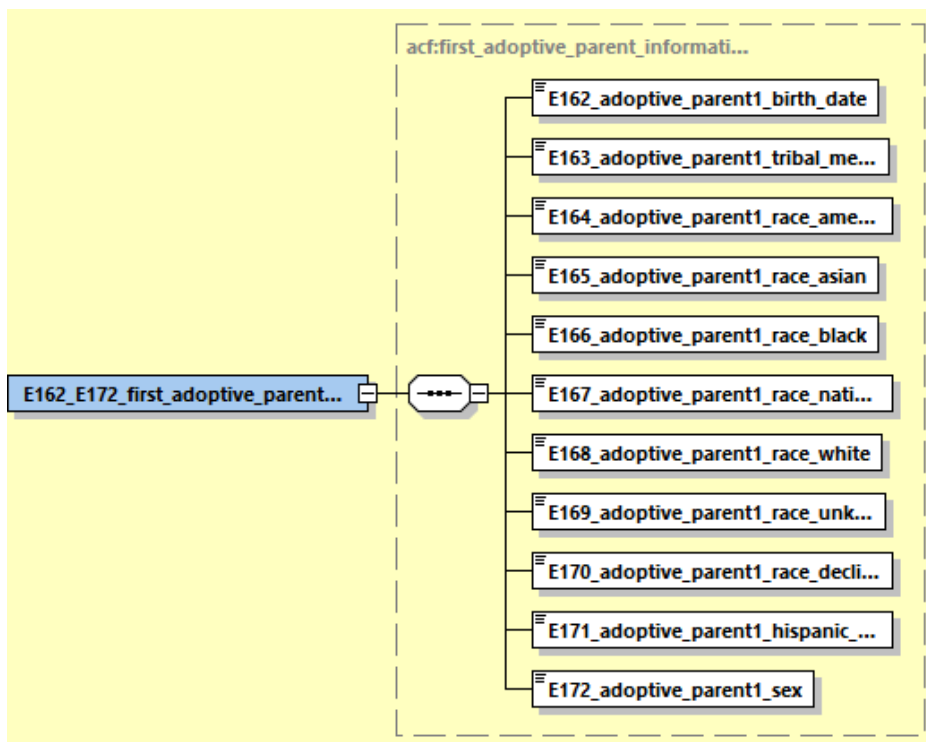

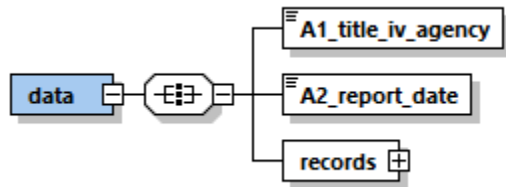

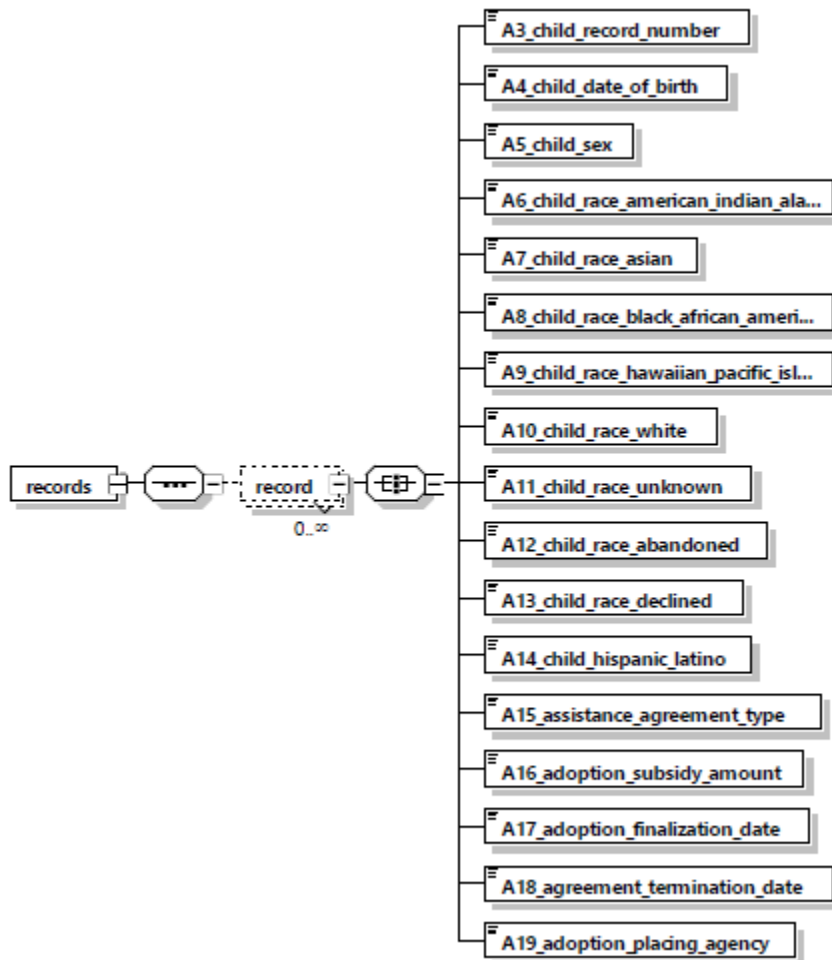
